Introduction

Iron (Fe) is an essential metal that is involved in many physiological processes in the plants. Direction of Use

We recommend foliar application @ 1L/acre. For accurate rate will depend on crop needs. Tissue/soil analysis are best indicator to determine correct dose.

- Use enough water to cover the foliage.
- Always test compatibility before mixing two different products by jar test.

It is important to monitor crop needs and responses by maintaining an adequate tissue-testing program. When unfamiliar with the effects of foliar applications of minerals it is recommended to perform small-scale field trials.
