## Introduction

## Direction of Use

**General Recommendations:** 3-4 L/1000 sq. m.

**Greens & Tees:** 100-300 ml/ 100 Sq. Meters.

**Fairways & other:** area 125-375 ml/100 Sq. Meters.  
(Apply as needed throughout the growing season).
